The Great Estates Program, available from the Cuyahoga County Fiscal Officer, provides all the information and tools needed to stay out of probate court and avoid unnecessary costs and delays in settling an estate.

Nominations are now being taken for open positions. The Nominating Committee, appointed by the Board of Directors, requests that any member desiring to be a candidate for any of the open offices submit a letter to the Nominating Committee in care of the credit union office declaring his or her intention. A photograph must accompany the letter of intention. All letters of intention and photos must reach the credit union office no later than Friday, February 20, 2026 in order for the candidates' names and pictures to be printed on the ballots for the Annual Meeting.

Nominations from the floor will also be in order at the Annual Meeting. Voting procedures under the bylaws of this credit union are printed here.

OFFICIAL VOTING PROCEDURES

To obtain a ballot for this election, each member will be required to register in person at the registration desk at the entrance at Brennan's Party Center, Cleveland, Ohio. The registration desk will be open at 11:00 a.m., one hour prior to the scheduled time of the meeting which will start promptly at 12:00 Noon. Nominations from the floor will be in order, therefore, each member is encouraged to refrain from marking his or her ballot until all nominations are closed.

Joint account holding members are each entitled to one vote provided that the share balance of the joint account is at least ten dollars (\$10.00). If a member does not have a joint tenant, then a five dollar (\$5.00) share balance is required. Members must be present to cast their ballots. Voting by proxy or by mail is not permitted under our bylaws. All ballots must be cast at the shareholders' meeting in compliance with the state statute.

Ballot boxes will remain open until such time as voted upon by the membership in attendance to close them. We ask that all members continue to preserve decorum as in previous years, during which time the business sessions and elections take place. The high standards which we have set in past shareholders' meetings have enabled us to accomplish lengthy meetings in a minimum amount of time.

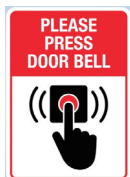
